SHARON TOWNSHIP ZONING

Attention all voters !! The zoning law that has been protecting your property will be up for repeal on the May ballot. A private individual wishing to get concession privileges in a residential area has been turned down by the County Zoning Board, the Appeal Board, and the County Commissioners. As a final attempt to establish a nuisance, this individual, through petition, has been able to bring the repeal of zoning before the voters in the May election. If this repeal becomes effective it will mean the entire Township will be thrown open to unrestricted zoning. Do you want an hot-dog stand next to your home? If not, vote against repeal of zoning!

Note: If you did not register before the last election, you must do so at the Board of Elections, 214 1/2 South High St. (second floor) on or before March 22, 1950.
